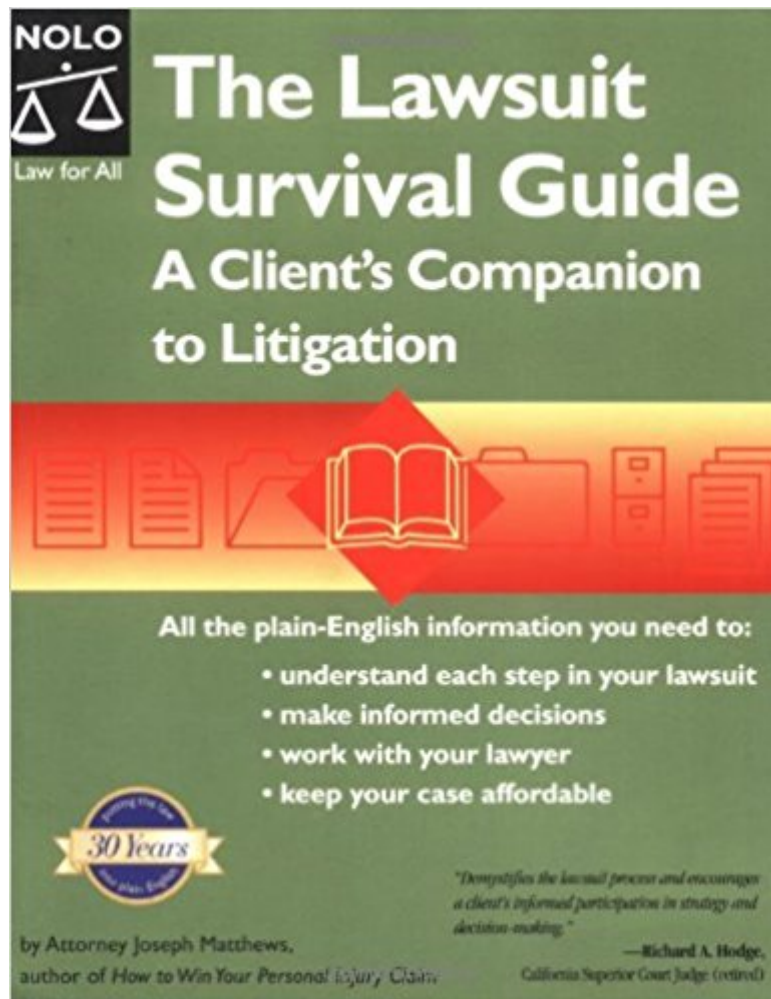

I had to file a lawsuit over a civil matter. This book is valuable resource for both plaintiffs and defendants. It describes the basic process of the the US legal system and defines many of the terms you encounter. It reduces much of the confusion and uncertainty of interacting with the legal system including your own lawyer. The information can help you save money in legal fees by pointing out how you can do some of the work instead of paying your attorney to do it for you. With all of that said, this book is not state specific so you will have to look up specifics like filing deadlines, length of time to file various forms of paperwork, notification requirements, etc. for your

state.

Having to go to court several times, this book proved to be a valuable resource. It taught me what to expect from the legal system in a step by step form. It covers how to choose an attorney to all the trial procedures. It makes the whole idea of going to court a lot easier. The authors give honest information on every part of the trial and the trial process. You will learn how to file a complaint to answering a complaint.
